### First Aid Measures

### Accidental Release Measures

**Spillage**: Remove ignition sources. Provide adequate ventilation. Avoid excessive inhalation of vapours.

**Environmental precautions**: Keep away from drains, surface and ground water, and soil.

### Handling and Storage
